

In the search of his dormitory room, a bag of suspected drugs were located and were sent to the lab to test. A verizon brand "flip" phone and a Acer brand laptop were seized during the search of the room. A search warrant was obtained for the contents of these items as well.

Detective Lucas and Cargill extracted the information from these items and were able to transfer the information onto a hard drive for me to view. The files are too large to burn onto a thumb drive or compact disc.

Verizon "flip" STYLE PHONE:

This phone had items from 2015 and did not have anything of evidentiary value on it.

ACER LAPTOP:

This laptop was examined and nothing of evidentiary value was located on the computer.

IPHONE CELL PHONE:

This cell phone is the cell phone that Nicholas Remington currently uses. It was seized from him on the night of the robbery (17903003767) and had recently dated activity on it. I did not find anything of a criminal nature on the SMS (text messages) or MMS (text messaged with photographs), video's, photographs, Device locations, or email portions of the phone.

In looking at the "Chats" portion, it appears that this is the way the Nicholas Remington communicates in reference to his drugs and purchasing of drugs. The information was from his "Facebook Messenger" social media site. The correspondence with a subject named "ixiivii austin" documented a long conversation about the purchasing and selling of drugs. In the conversation, "ixiivii Austin" mentions his address of and later in talking with Nicholas. "Austin" also gives his phone number to Nicholas Remington as In researching this information on the law enforcement intelligence website "accurint.com" it shows that this information comes back to Austin Kittrell who resides at This phone number is also listed to Kittrell. It is thereby thought that "ixiivii Austin" is "Austin Kittrell".

These "chat" messages cover a long period of time and will be forwarded to the prosecutor on a Compact Disc, due to the length and number of messages between Kittrell and Remington. These messages document the purchasing of drugs from Kittrell, by Remington, who is thought to be selling them out of his room at the West Quad dormitory where the suspected bag of MDMA was located at.

CHAT MESSAGES:

On 6/3/17 Remington contacted Austin and asked "Know anyone with Molly?" Molly is the street name used for MDMA and Ectasy.

Austin replies back with "My friends name is molly and then promptly called Remington on the phone.
