Hi Chris, hope you have been well. I'm forwarding you recent emails from Linda Thom, Denis Preka's mother. I am also going to forward you recent email correspondence from Jaimie Thom. I have explained to both, many times, why the Oakland County Prosecutor's Office dismissed the criminal charges against Nicholas Remington. I have done so in phone calls, letter, and emails. It is clear that your clients do not agree with this decision. I do not fault them for that, if I lost a loved one I wouldn't care about reliability or admissibility of evidence either. Since that time, your clients have repeatedly accused me, and my office, of unethical behavior. They have also requested another copy of the Snapchat search warrant returns because they stated the format in which your office gave to them was difficult to review. Regardless of their allegations, I complied with their request out of sympathy, and because I was informed that this was already disclosed to your office in response to a FOIA request. I provided them with what I hope is a more readable format of the Snapchat records. From the emails below you can see that they have additional requests, along with additional allegations.

I write this to you for two reasons. The first is to make you aware of this email communication and the Snapchat records. The second is to let you know that I will not subject myself to any additional communication with either Mr. or Mrs. Thom. All communication with this case, to the extent any is necessary, will go through you. Please inform your clients of such.
